Advocacy

ACSS remains fully engaged in representing your individual interests at each State Agency and Department. Our advocacy on behalf of all of our members with CalHR and the Administration is expanding and continues to yield progress on long-standing issues such as salary compaction, benefit preservation and minimizing the impact of California's budget issues on our members' jobs. These efforts have led to several special salary adjustments for classifications that have been experiencing egregious salary compaction issues. In addition, after much effort by ACSS staff, we are glad that the Administration agreed to postpone the Return to Office mandate and we continue to work with our members on a case-by-case basis to ensure that telework is
